


## **Spring Newsletter for our Zero Pollution Supporters 2023**

We are very excited about the opportunities for Stormwater Shepherds UK during 2023. It's going to be an incredible year for stormwater management as there is so much press interest in sewer overflows, and the government are hoping to introduce mandatory sustainable drainage (SuDS) on all new homes built in the future. If new homes have sustainable drainage, there will be less stormwater rushing into our sewers when it rains and overflows are less likely to discharge sewage. Stormwater Shepherds UK will work hard this year to make the very best of these opportunities to improve stormwater management, not only on new developments, but also in existing developments, and in our towns and cities.

We were really pleased to be asked to help Natural England and CIRIA to write new guidance on the use of Sustainable Drainage Systems to reduce phosphorus pollution from residential developments across parts of England where river pollution is unacceptably high.



The new CIRIA guidance is helping developers to reduce pollution


We visited this new housing estate in Salford and it has no green space and no sustainable drainage. Stormwater Shepherds wants to see an end to developments like this.



Our Director of Operations, Jo Bradley, has attended some influential events since Christmas, taking the opportunity to meet other professionals working in the field of stormwater management. She was at the WWT Wastewater Conference in Birmingham where she Chaired a panel discussion about the future delivery of SuDS and the skills gap that we might face if we do not move quickly to train new SuDS professionals with experience of water quality management and ecology.
